This course is designed to expose students to various characteristics of policymaking in the American political system. Relying broadly, but not limited to, political science research, we will examine some of the political institutions and key actors that develop American public policy. We will consider several venues for policymaking – including agenda setting, legislation, and interest group activity – and examine how political institutions shape and constrain policymaking at the local, state, and national level.

Course Format and Requirements

This course meets once a week. Attendance and active participation are important aspects of your class experience and evaluation. The course meetings will consist of a combination of lectures, discussions, and group work. In addition to reading the assigned materials, students must come prepared to discuss current events as well. Each class will begin with a discussion of current events in American politics.

Final Paper:

For the final paper, you will choose an actual, current policy issue (public safety, health, immigration, education, etc.). Identify a government agency, office of an appointed or elected official, or community organization that is working to address that particular policy issue. Then you will identify an individual within that agency, public office, or organization that you will interview for the project. The purpose of the interview is to learn about how the individual reached her/his position (education, professional experience, etc.) and how they are working to address the policy issue you have chosen. In a 10-page paper you will:

- Describe the policy issue
- Explain why the agency/office/organization you have chosen is appropriate
- Provide background information on the individual you have interviewed
- Describe the individual and agency/office/organization's effort to address the policy issue

Finally, you should integrate and apply the concepts you have learned throughout the course to provide an analysis of the policy issue and the work of the agency/office/organization in this matter. Applying what you have learned in class, assess the challenges and opportunities for the agency in addressing the issue.

The paper should be **no more than 10 pages of double-spaced text** (the page limit excludes references and interview protocol). The paper is due on **May 5 via email. Late papers will not be accepted.**

Final Presentation:

Students will present the findings from their final papers on April 27. Presentations should be 10 minutes in length, followed by a Q&A session.

Course Description

This course is designed to expose students to various characteristics of policymaking in the American political system. Relying broadly, but not limited to, political science research, we will examine some of the political institutions and key actors that develop American public policy. We will consider several venues for policymaking – including agenda setting, legislation, and interest group activity – and examine how political institutions shape and constrain policymaking at the local, state, and national level.

Course Format and Requirements

This course meets once a week. Attendance and active participation are important aspects of your class experience and evaluation. The course meetings will consist of a combination of lectures, discussions, and group work. In addition to reading the assigned materials, students must come prepared to discuss current events as well. Each class will begin with a discussion of current events in American politics.

Discussion/Participation:

Our class will benefit greatly from active participation from all class members. The unique analysis and personal experiences that each of you contributes to the discussions will help educate the rest of us. Class participation consists of the following components: (1) attending class; (2) Be prepared by doing the required readings (3) engaging regularly in class discussions.

Papers:

Students are expected to submit 2 papers throughout the semester. The papers will provide a summary and analysis of the week's reading assignments. Students will choose which weeks to submit the assignments. Each paper should be 3 pages in length and should include the following: major argument(s); major findings; analysis and critique of the readings; and two questions generated by the readings. Papers are due via e-mail (Domingo.Morel@rutgers.edu) by 7pm on Wednesdays.

Final Paper:

For the final paper, you will choose an actual, current policy issue (public safety, health, immigration, education, etc.). Identify a government agency, office of an appointed or elected official, or community organization that is working to address that particular policy issue. Then you will identify an individual within that agency, public office, or organization that you will interview for the project. The purpose of the interview is to learn about how the individual reached her/his position (education, professional experience, etc.) and how they are working to address the policy issue you have chosen. In a 10-page paper you will:

- Describe the policy issue
- Explain why the agency/office/organization you have chosen is appropriate
- Provide background information on the individual you have interviewed
- Describe the individual and agency/office/organization's effort to address the policy issue

Finally, you should integrate and apply the concepts you have learned throughout the course to provide an analysis of the policy issue and the work of the agency/office/organization in this matter. Applying what you have learned in class, assess the challenges and opportunities for the agency in addressing the issue.

The paper should be **no more than 10 pages of double-spaced text** (the page limit excludes references and interview protocol). The paper is due on **May 5 via email. Late papers will not be accepted.**

Final Presentation:

Students will present the findings from their final papers on April 27. Presentations should be 10 minutes in length, followed by a Q&A session.
